

Update on jurisdictions in Burlingame Hills

As you may know, our community is split evenly into two political jurisdictions: an Unincorporated area and a City area, each with about 425 homes.

If you live in the Unincorporated area, you are represented directly by the San Mateo Board of Supervisors. If you live in the City area, you are represented in the City Council by one of two City Councilmembers, depending on your address.

Last year, for legal reasons, the City

of Burlingame changed from at-large elections to district elections.

Subsequently, the City homes on and near Skyline Drive and on and near the upper part of Hillside Drive are in City Election District 1 and the City homes on and near Summit Drive and on and near Alvarado Avenue are in City Election District 3.

Next month, there will be an election for District 1 but not District 3. District 1 is represented by Andrea Pappajohn and District 3 is repre-

sented by Michael Brownrigg.
